

Aimee Zeitz-Gruber,

I am writing to make sure you are aware of the Malaika and Xayah Robinson-Lopez case and the catastrophic damage this child-welfare case continues causing to two young children and to an entire family across multiple generations.

My name is Ricky G. Robinson. I am the paternal grandfather of Malaika and Xayah Robinson-Lopez. Their mother, father, grandparents, relatives, and advocates continue fighting for them. Their mother completed her court-ordered case plan. Their family was approved and willing to care for them. Yet Malaika and Xayah remain separated from their family, and the consequences of that separation continue to be severe.

This case has involved hospitalizations, screaming, emotional breakdowns, restrictions on family contact, attacks on kinship placement, retaliatory actions following protected speech and public advocacy, and the destruction of family relationships these children continue trying to hold onto. Malaika and Xayah are not children without family. They have a family that loves them, wants them, and continues fighting for them.

The damage does not stop with the children. Parents, grandparents, seniors, and elderly family members have been pulled into years of forced separation, grief, government conflict, and relentless efforts to defend their family and constitutional rights. Their great-grandmother died while still fighting to see Malaika and Xayah returned to their family. The girls will never get that time with her back.

My mother should have been celebrating her 89th birthday today. Instead, she died while still fighting to see Malaika and Xayah returned to their family.

There are also serious questions involving kinship, Resource Family Approval, retaliation for protected speech, the treatment of nonrelative caregivers, federal and state taxpayer funding, Title IV-E, and whether public money is being used to maintain separation rather than support safe family preservation and lawful permanency. Those issues deserve scrutiny for fraud, waste, and abuse.

I do not know what you personally have been told about this case or how much of it has reached your level. That is exactly why I am writing. Leadership within Child and Family Well-Being should be aware that this family exists, that Malaika and Xayah have family, that the harm is ongoing, and that people inside and outside San Diego County continue documenting and examining what is happening.

I am contacting officials, attorneys, journalists, advocates, federal agencies, elected representatives, and others capable of bringing outside scrutiny to this case. I am not

asking you to take my word for anything. Records, recordings, videos, communications, court history, timelines, and other evidence exist and are being preserved.

This letter is intended to make sure you are aware of the Malaika and Xayah Robinson-Lopez case and the ongoing harm this family is reporting.

Malaika and Xayah are not children without a family. They are children being kept from one.
