To the Board of Supervisors and Every Government Actor Participating in This System:

You stole human life from our family under the guise of child protection. Malaika and Xayah are alive, yet their mother, father, grandparents, siblings, and extended family are forced to live as though they have been taken by death. You have inflicted profound shock on their mother Evelyn Lopez, continuing trauma on our children, and a form of living grief across an entire family.

I continue writing Washington, D.C., federal authorities, state officials, journalists, and anyone else with the power to investigate what San Diego County has done. I am demanding the strongest lawful accountability available for every person responsible for abusing government power to separate children from their families, conceal harm, retaliate against those who expose it, and prolong that suffering.

I am also writing elected officials in Washington, D.C., demanding the strongest criminal penalties the law can impose on government actors and private individuals who knowingly participate in the kidnapping, trafficking, abuse, concealment, and destruction of children and families. Where lawmakers determine that conduct warrants the ultimate penalty, I am asking them to act.

This is a grotesque miscarriage of justice. What kind of government authority watches children suffer, watches a mother pushed into profound shock, watches grandparents and siblings lose living children, and still keeps pressing forward as though cruelty becomes acceptable simply because officials have badges, titles, courtrooms, and government power? That is not compassion. It is authoritarian cruelty — the same kind of dehumanizing logic history teaches us to recognize in regimes that treated families and human beings as objects the state could control, remove, and destroy.

I want to know what made this system so sick that people can look directly at the damage being done to Malaika, Xayah, Evelyn, and our entire family and continue participating in it. What happened to basic humanity? What happened to conscience? What happened to protecting children instead of protecting the machinery hurting them?

And understand this clearly: I have also been campaigning publicly to make sure voters know exactly how members of this Board respond when families come before you begging for their children. Walking out while families plead for help is something voters deserve to remember. I intend to keep reminding them.

What is happening to our family is not random bureaucratic failure. It is a grudge-driven abuse of government power that escalates after we speak publicly, exercise our First Amendment rights, and expose misconduct. Child and Family Well-Being, County Counsel, and the guardian ad litem's office operate together while the pressure on our family intensifies. I possess evidence documenting deliberate psychological pressure directed at Evelyn Lopez and conduct that goes far beyond ordinary case management. I am not laying that evidence out for you in this letter. I am preserving it. When the complete record is examined, the people responsible will have to explain under oath what they were doing, why they were doing it, and why the pressure escalated after our family refused to remain silent.

This is a grotesque miscarriage of justice, and I will keep exposing it until the people responsible are forced to answer for what they have done and what they continue doing.
